

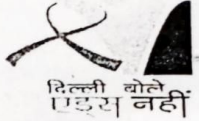

This is in reference to the D.O. letter of even number dated July, 13, 2021 from the Secretary, Health & Family Welfare, GNCTD and letter even no. dated 23/06/2022 (copies enclosed) vide which it was requested to implement the provisions of the HIV and AIDS (Prevention and Control). The Govt. of NCT of Delhi has also notified the State Rules viz. "The Delhi Human Immunodeficiency Virus and Acquired Immune Deficiency Syndrome (Ombudsman and Legal Proceedings) Rules, 2022" in Delhi Gazette Extra Ordinary dated 2nd November 2022, wherein all District Magistrates of National Capital Territory of Delhi have been designated as Ombudsman for their respective Revenue Districts. In this regard, It is to inform you that DSACS has received information of designating Complaint Officer only from 26 Hospitals/departments/institutes till date (list enclosed). The information of Complaint officer is yet to be received from your Hospital/institute.
