- (c) Public dealing in day to day functioning.
- (d) Department engaged in regulatory functions.
- (e) Department engaged in Regulation and Collection of public revenue.
- (f) Where there is likelihood of coloured exercise of discretion or excessive discretion.
- (g) Departments issuing license/ Permission/Permits/ NOC/Recognitions and such activities known by any name.
- (h) Any other information on nature of working of department suggesting high incidence of corruption.

The list of sensitive Departments as well as posts is vital requirement for operation of Agreed List and Doubtful Integrity List. The officials figuring in these lists are NOT to be posted in sensitive Departments/posts.

The cadre controlling authorities are requested to operate the list of sensitive departments / posts as per instructions applicable for officials appearing in Agreed List/ Doubtful Integrity List. As far as ex-cadre posts in Departments/Autonomous Bodies are concerned, the concerned HOD/Administrative Head are requested to implement the aforesaid instructions as applicable and they shall be responsible for compliance of instruction in letter and spirit. The respective Cadre Controlling Authorities and HODs of ex-cadre departments/posts are required to ensure mandatory rotation of officials from sensitive departments/posts as per guidelines of CVC circulated from time to time.
