Decision: In the absence of Hon'ble Dy. Chief Minister/Minister (Vigilance), Hon'ble Chief Minister proposed the following for consideration of the Council of Ministers:-

Hon'ble Dy. Chief Minister / Minister (Sports/Vigilance) mentioned the following:-

- (a) Over the past few months, the Govt. of National Capital Territory of Delhi received several complaints by retired Indian Cricketers, that included among them a few legends of the game, about a series of alleged malpractices and financial irregularities in the functioning of Delhi & District Cricket Association (DDCA) and the maladministration of the game of cricket in Delhi. In July, 2015, the Government also received a letter from the Ministry of Youth Affairs and Sports, Govt. of India, requesting to take appropriate action into matters of irregularities committed by Delhi & District Cricket Association.
- (b) Pursuant to these complaints and Govt. of India communication, the Govt. of NCT of Delhi set up a three member committee to enquire into the matter. The Committee made several recommendations with regard to cleaning up the affairs of DDCA. One of the recommendations was to consider appointing a Commission of Inquiry under the Commissions of Inquiry Act, 1952 to probe various wrong doings/allegations among other issues pertaining to DDCA.

After deliberations, the Council of Ministers resolved to constitute a Commission of Inquiry under Commissions of Inquiry Act, 1952, with following terms & conditions:-

- The Commission shall be a one member Commission, headed by Sh. Gopal Subramanium, Senior Lawyer (Supreme Court) and former Solicitor General of India.
- ii) As informed by Sh. Gopal Subramanium, he shall charge Rs. One for discharging his duty.
- iii) The Commission of Inquiry shall conduct inquiry into the:
 - working, management and administration (including alleged financial irregularities) of the DDCA;
 - b) whether such practices have been conducive to the game of cricket;
 - recommendations to make DDCA an institution compatible with international standards;

- identify any acts of omission and commission by DDCA and its officer bearers during the period between January 1, 1992 and November 30, 2015 and fix responsibility;
- e) and whether such acts of omission need to be pursued and if so, in what manner;
- f) recommendations to make DDCA an effective and transparent body so that it could promote the glorious game of cricket and identify and nurture talent.
- iv) The Commission shall submit its report as soon as possible but not later than three months from the date of its first sitting.

The notification shall be issued by the Director of Vigilance, Govt of NCT of Delhi.

The other terms and conditions of the Commission shall be finalized by the Directorate of Vigilance, Govt. of NCT of Delhi.

This Cabinet resolution may be placed before the Legislative Assembly for consideration and approval.
